

# Terms & Conditions for \$CROWX Presale

**Effective Date:** August 25, 2025

These Terms & Conditions (“Terms”) govern your participation in the \$CROWX token presale (“Presale”). By connecting your wallet, purchasing tokens, or otherwise participating, you agree to be bound by these Terms. If you do not agree, you must not participate.

## 1. Eligibility

- You must be at least 18 years old to participate in the Presale.
- By participating, you confirm that your participation is legal under the laws of your jurisdiction.
- Residents of jurisdictions where token sales are prohibited (including, without limitation, the United States, China, and other restricted regions) may not participate.

## 2. Nature of Tokens

- \$CROWX tokens are utility tokens and are not intended to be securities, investments, or financial instruments.
- Holding \$CROWX does not grant any ownership rights, equity, voting rights, or profit-sharing in any entity.
- Tokens are provided on an “as is” basis, without guarantees of future value or performance.

## 3. Token Purchases

- All purchases of \$CROWX tokens during the Presale are final and non-refundable.
- The price of tokens during each stage of the Presale is fixed and will not be retroactively adjusted.
- You are responsible for ensuring you send funds to the correct wallet address. We are not responsible for lost or misdirected funds.

## 4. Referrals

- Participants may use referral links to invite others to the Presale.
- A referral reward of 5% from the referred participant’s token purchase is allocated automatically.
- Referral rewards are final, non-transferable, and subject to change at the team’s discretion.

## 5. Risks

By participating, you acknowledge and accept the following risks:

- The value of tokens may fluctuate and could become worthless.
- Blockchain technology is experimental and may fail, be attacked, or experience downtime.
- Regulatory changes or government actions could impact your ability to hold, use, or transfer tokens.
- You may lose all funds spent on token purchases.

- The \$CROWX team and associated parties shall not be liable for any losses, damages, or claims arising from participation in the Presale.
- We make no guarantees regarding token value, listing, or project success.
- You participate entirely at your own risk.
